3. Minutes of 2017-1 AGM

a. presentation of statement of accounts

Toss Gascoigne moved to accept the statement of accounts for the past financial year; Suzette Searle seconded ==> motion carried

b. determination of annual membership fee

(Delayed due to overhead Powerhouse Museum announcement)
Lisa Bailey moved to retain the annual membership fee at \$189 for members and
\$87 for student and associate members; Adam Selinger seconded ==> motion carried

c. determination of capitation to be returned to branches

Ask for a financial snapshot each year from the branches. New Treasurer will need to call for this.

The other 10% need to have an idea that will benefit members and also provide access to other members. The process is not onerous. The capitation has increased with membership fees.

Capitation arrangements remain unchanged, with 10% of membership fees going to branches that are constitutional, and another 10% for each branch being retained in a central pool.

Branches must be constitutional to receive the base level of capitation (i.e. have an elected President) and provide a very simple annual financial update to the National Treasurer.

Phil Dooley moved that capitation arrangements remain unchanged for the ASC financial year; James Hutson seconded ==> motion carried

d. determination of honoraria

Craig Cormick noted that the following honoraria are payable, in recognition of those who take on these roles. At the last AGM, this item was not discussed:

Honoraria of \$1000 each payable to the President, Secretary and Treasurer Honoraria of \$500 each payable to the two grants program co-managers – to be discontinued on request of former grants program co-managers.

Suzette Searle moved that honoraria arrangements can be paid for 2018 and continued for 2019; Phil Dooley seconded motion ==> carried

e. appointment of auditor

Working with bookkeeper to appoint a suitable auditor.

Phil Dooley moved that Vivienne Seedsman be appointed as the auditor; Toss Gascoigne seconded motion ==> carried

f. appointment of public officer

Lisa Bailey moved to appoint Suzette Searle as the Public Officer; Astha Singh seconded ==> motion carried

g. preview of 2019 budget

ASC AGM President's report – 2018

The ASC, like the whole world, is confronting serious change.

2018 has been a year of tensions and stresses and changes across the globe, with pushes for new ways of managing an uncertain future.

Likewise for the ASC, it is becoming apparent that we are at a point in our evolution where we need to consider what shape our future.

Over time our membership has changed subtly, and member involvement has changed. We have a huge diversity of members, which is both an asset and an issue to work with.

How do you provide services that work for everyone when interests are so diverse?

We are so diverse in fact that almost everything you say about the ASC membership – whether it be anecdotal or based on data – is proven wrong as much as it is proven right.

So determining what do members want from the ASC, and what do members not want from the ASC, can therefore be difficult to capture.

But it is time for the organisation to seriously consider what shape we needs to be to best work for our members in the years ahead.

We are living in a post-trust, post-truth, post-expert world, with increased political tensions, increased divergence and reduced trust in media, continued evolution of social media – and reduced budgets for many.

How do we best operate in such a world is a question we need to understand individually and also as an organisation.

Perhaps we need to look at the things that unite us, to provide a clarity of our common vision for how science communication professionals best work in this changing world, and build on that to understand how the ASC best operates in the years ahead.

I am confident that our members, our branches and our national executive have the talent and commitment to achieve this.
